ASSUMPTION OF RISKS I am aware that swimming, use of waterfront property, use of school dock, participating in lessons, clinics, sessions, races, camps or guided tours involves many risks, dangers and hazards including, but not limited to: drowning; changing weather conditions; exposed rock, earth and other natural objects; trees, tree wells, tree stumps and forest deadfall; steep accents or descents; variable and difficult conditions; including, but not limited to: roads, road-banks; vehicles, equipment or structures; overexposure to the sun; fatigue, dehydration and overexertion, collision with other persons, staff, volunteers or spectators; encounters with wild or domesticated animals, loss of balance or control; slips, trips and falls; negligent first aid; failure to act safely or within one's own ability or to stay within designated areas; negligence of other persons; and NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE. I am also aware that the risks, dangers and hazards referred to above exist throughout the school property and that many hazards are unmarked. I am aware that there is no lifeguard on duty and I swim at my own risk. I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT In consideration of the Releasees accepting my application for use of private waterfront property, school dock, and swimming, , parking lots and access roads (hereinafter "the facilities"), I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my use of or my presence on the facilities or DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT, R.S.B.C. 1996, c. 337 ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES THE FAILURE ON PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE.

2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party, resulting from my use of or presence on the facilities.

3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;

4. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia and no other jurisdiction; and

5. Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of British Columbia, and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.

In entering into this Release Agreement I am not relying upon any oral or written representations or statements made by the Releasees with respect to swimming, use of waterfront property and use of school dock other than what is set forth in this Agreement.

PHOTO/VIDEO RELEASE - I consent to photographs and/or video taken of me being used for advertising, promotional or marketing purposes.

WATERFRONT AND DOCK RULES

1. NO LIFEGUARD ON DUTY – Swim at your own risk and use waterfront and dock responsibly
2. Dock will often be locked, however if it is unlocked it may be used
3. No running on dock
4. Children under 16 must be accompanied by an adult
5. Use of waterfront property and dock is for St. John Academy families/staff only, however one friend per child may accompany the family when an adult is present.
6. Use of School equipment, canoes, kayaks etc. is prohibited
7. Use of firepit is prohibited
8. No events or parties allowed
9. Take out what you bring in, do not leave garbage or personal belongings behind
10. Please practice social distancing, other families may be using the waterfront at the same time.
11. Please comply with noise by-laws
12. Use of waterfront and dock is not allowed during school events or when reserved for school visitors.
